Chairman Alex Lieblong noted a quorum and asked if there were any additions or corrections to the minutes of the May 4, 2019 meeting. There were none noted.

Commissioner Mark Lamberth made a motion to approve the Ruling of the Judges at Southland. Commissioner Steve Landers seconded the motion; Motion Passed

Commissioner Bo Hunter made a motion to re-open the application process if a letter of support is received within 90 days. Commissioner Denny East seconded the motion; Motion Passed


Commissioner Butch Rice made a motion to approve the EGS Games. Commissioner Steve Landers seconded the motion; Motion Passed.
